

CYPRESS CREEK HIGH SCHOOL FFA BOOSTER CLUB, INC. STOCK TRAILER / POPPERS AGREEMENT

(To be completed by parent or guardian)

Anyone pulling the Cypress Creek High School FFA Booster Club, Inc. ("CyCreek FFA Booster Club") stock trailer/poppers **MUST** be 21 years or older. A current driver's license must be on record and the pulling vehicle must have a current license plate, approved through the vehicle inspection requirements of the State of Texas, and proof of liability insurance must be documented. The trailer is to be used for the purpose of pulling livestock related to the Cypress Creek High School FFA Chapter and not used for any commercial purposes, unless authorized by the appropriate Booster Club representatives in advance. It is the parent/guardian's responsibility to contact the CyCreek FFA Booster Club if there are any changes to the insurance information provided below.

The CyCreek FFA Booster Club affirms that to the best of their knowledge and belief that Stock Trailer/Poppers are in sound and safe condition and free of any known defects or faults which would affect its safe operation under normal use.

- The trailer/poppers will be used for animals relating to the Cypress Creek FFA program.
- My vehicle insurance is current and covers no less than the minimum coverage of General Liability vehicle insurance as required by the State of Texas.
- The vehicle in use for towing **must be at least a ½ ton truck, have a 2-5/16-inch hitch ball** and is current with the Texas vehicle inspection program.
- I hereby agree that I shall be held fully responsible for any and all loss of or damage to the stock trailer/poppers during the use of the stock trailer/poppers under this Agreement whether caused by collision, fire, flood, vandalism, theft or any other cause.
- I accept total responsibility for any and all repairs and/or replacement of the trailer/poppers in the event of any damage that occurs for reason by any party.
- I agree and understand that the Booster Club reserves the right to obtain an estimate for costs associated with any damages to the stock trailer/poppers. If the Booster Club pays for repairs as a result of damages I caused, I will be responsible for payment to the Booster Club.
- I will make no claim against the CyCreek FFA Booster Club or the Cypress Creek FFA Chapter for any damage than may occur as a result of the use of this trailer/popper.
- I assume all liability associated with the use of the trailer/poppers during the time of possession.
- I will sign out and sign in on the record log as required for use.
- I will clean the trailer/poppers after each use, and will forfeit further use of the trailer/poppers if it was not signed out and used appropriately, or if not cleaned adequately after use.

**CYPRESS-FAIRBANKS ISD NOTICE OF DRIVER LIABILITY
(Pulling/Utilizing Trailers)**

I recognize and acknowledge that I am voluntarily driving my privately-owned vehicle and pulling/utilizing a district-owned trailer to transport property owned by Cypress-Fairbanks ISD and/or CFISD students to a district event/activity or for other purposes associated with a district event or activity.

I certify that I am 21 years or older, possess a valid driver's license and the pulling vehicle has current license plates, approved through the vehicle inspection requirements of the State of Texas, and I possess documented proof of liability insurance. Furthermore, I agree to obey all traffic laws and to drive directly to and from the event/activity.

I also acknowledge that I shall be held fully responsible for any and all loss of or damage to the trailer or its contents during the use of the trailer under this Agreement whether caused by collision, fire, flood, vandalism, theft or any other cause. I agree to absolve, exonerate and hold the district and/or its institutions harmless from liability or any risks associated with my use and possession of the district-owned trailer. Risks include, but are not limited to, all liability associated with my operation of a motor vehicle, pulling a trailer, any and all injuries, and any and all damages to property or contents resulting from my use or possession of the trailer. I accept total responsibility for any and all repairs and/or replacement of the trailer in the event of any damage that occurs for reason by any party. I will make no claim against Cypress-Fairbanks ISD for any damage that may occur as a result of the use of this trailer.

I further understand that my personal property (contents) is not covered by any district property insurance coverage, and I also acknowledge that my personal automobile coverage may not cover damages to the contents in my vehicle or in the district-owned trailer in the event of an accident.

I have read and understand the above information and have been made aware of my potential liability.
